The Permanent Mission of Algeria to the United Nations presents its compliments to the Permanent Representatives of the Czech Republic and the Saint Vincent and the Grenadines, in their capacity as co-facilitators appointed by the President of ECOSOC for the intergovernmental negotiations of the Ministerial declaration of the 2025 High-Level Segment of the ECOSOC and the High-Level Political Forum on Sustainable Development (HLPF), and with reference to their Letter dated February 25th 2025 requesting member States to submit, by Friday 07th March 2025, written comments on the main elements for the said declaration, has the honour to forward in this regard the main inputs of the Algerian delegation, as follows:

- Reaffirm that the 2030 Agenda is guided by the purposes and principles of the Charter of the United Nations, including full respect for international law, and express support for the Pact of the Future, which aims to accelerate the implementation of the 2030 Agenda.
- Reaffirm the commitment to the purposes and principles of the United Nations Charter. In this context, the Algerian delegation emphasizes the paramount importance of the principle of self-determination of peoples under foreign occupation and strongly advocates for its inclusion in the HLPF Ministerial Declaration, as was prominently underscored in the 2024 HLPF Ministerial Declaration.
- Commit to bold, ambitious, accelerated, just and transformative actions, anchored in international solidarity and effective cooperation at all levels.
- Remain resolved to end poverty and hunger everywhere, to combat inequalities within and among countries, to build peaceful, just and inclusive societies, to respect, protect and fulfill human rights and to ensure the lasting protection of the planet and its natural resources.
- Reaffirm all the principles of the Rio Declaration on Environment and Development, including, inter alia, the principle of common but differentiated responsibilities.
- Recognize the special challenges facing all developing countries in pursuing sustainable development, in particular African countries.
- Remain resolved to create conditions for sustainable, inclusive and sustained economic growth, shared prosperity and decent work for all, and equal pay for work of equal value, taking into account different levels of national development and capacities.

- Reaffirm our resolve to realize our vision of a world with access to inclusive and equitable quality education, universal health coverage including access to quality essential health-care services, social protection, food security and improved nutrition, safe drinking water, sanitation and hygiene
- Recognize the urgency of providing predictable, sustainable and sufficient development finance to developing countries.
- Take action to bridge the digital divides and spread the benefits of digitalization through technology transfer. Expand participation of all countries, in particular developing countries, in the digital economy, including by enhancing their digital infrastructure connectivity, building their capacities and access to technological innovations.
- Ensure healthy lives and promote well-being for all at all ages, including by strengthening health systems and achieving universal health coverage. And address gaps in preventing, preparing for, and responding to current and future pandemics and health emergencies.
- Continue urgent efforts to implement the strategic objectives of the United Nations Convention to Combat Desertification, as well as preventing land degradation, drought and floods.
- Commit to bridging the science, technology and innovation divides and the responsible use of science, technology, and innovation as drivers of sustainable development and to increase the use of science and scientific evidence in policymaking.
- Commit to continuing to assist developing countries in avoiding a build-up of unsustainable debt and in implementing resilience measures so as to reduce the risk of relapsing into another debt crisis.
- Recommit to preventing and combating illicit financial flows and strengthening international cooperation and good practices on assets return and recovery. Reaffirm our commitment to strive to eliminate safe havens that create incentives for the transfer abroad of stolen assets and illicit financial flows.
