### Panel 2. International financing to address multidimensional vulnerability in SIDS

The mounting challenges that SIDS are facing as a result of their structural vulnerabilities that exacerbate impact of disasters and shocks cannot be addressed within their means. A more equitable system for countries to access development cooperation based on their actual needs, not on the GDP per capita alone, is essential to SIDS progress on the 2030 Agenda.

The session aims to foster discussions around the prospects of changing criteria and approaches in development cooperation to restore fairness and needs-based development financing. Specific financial instruments for SIDS may be required to ensure SDG progress is timely and sustainable.

At SIDS request, GA Resolution A/RES/75/215 called on the UN to develop a Multidimensional Vulnerability Index to define SIDS special case for development. The use of the MVI may include facilitating access to development cooperation.

This panel will analyze the suitability of the existing development cooperation system for SIDS' access to the resources they need to strengthen resilience and achieve the SDGs.

The division also oversees technical assistance provided out of seven IMF Regional Technical Assistance Centers. During her career at the IMF she has also helped design and implement tax and customs reforms in Asia, Europe, and the former Soviet Union, including in crisis countries. She has been a Financial Economist in the U.S. Treasury, where she worked on tax

Prior to his first appointment as minister, Singh was the Director of Budget in the Ministry of Finance and Deputy Auditor General in the Office of the Auditor General, as well as a chairman in the Governing Board of the Guyana Revenue Authority and the University of Guyana.

Between tenures as minister, he worked for the International Monetary Fund. As acting Minister, Singh also represented Guyana on the Boards of Governors of the

IMF, the World Bank Group, the Inter-American Development Bank, and the Caribbean Development Bank.



**Dr. Garry Conille - UN Resident Coordinator in Jamaica**. Mr. Conille brings more than 20 years of experience to his new position, most of them at the United Nations and international non-governmental organizations. Prior to the appointment, Mr. Conille served as Resident Coordinator in Burundi, from 2017 to 2020, and before that, as Under-Secretary-General for Programmes and Operations with the International Federation of the Red Cross and Red Crescent

Societies (IFRC), from 2015 to 2017. Mr. Conille was also Regional Director for the Africa Region at the United Nations Office for Project Services (UNOPS) from 2014 to 2015, having previously led the United Nations Development Programme (UNDP) Millennium Development Goals support unit, from 2008 to 2010. Following Haiti's 2010 earthquake, Mr. Conille served as Chief of Staff to the United Nations Special Envoy for Haiti, former United States President William J. Clinton, where he helped coordinate the country's reconstruction efforts. In 2011, Mr. Conille was appointed Prime Minister of Haiti, a position in which he served until 2012, when he became Senior Advisor to Liberia's President, Ellen Johnson Sirleaf, in her role as Co-Chair of the United Nations High-Level Panel of Eminent Persons on the Post-2015 Development Agenda.
