Member States have committed to achieve sustainable development for all nations and peoples and for all segments of society. The 2018 VNR Lab on LNOB identified good policies/measures taken to address specific needs of those who are left behind, as well as existing gaps, including lack of adequate national/local mechanisms to enable meaningful participation of vulnerable groups in the VNR process. New products and technologies are rapidly changing the landscape of financial services, especially in developing countries. Financial empowerment, including access to credit and banking services, can be a key element of a strategy to lift communities out of poverty. Many countries are incorporating inclusive finance strategies into development plans and integrated financing frameworks. Understanding how to align policy and regulation with the 2030 Agenda is critical, given the growing complexity in the financing landscape arising from technology and innovation, including new actors and instruments. 12		18:30–20:00	S-2726/27	<p>Storytelling and communication strategies for the SDGs – best practices from VNR countries</p> <p>The 2030 Agenda presents a number of communication challenges and opportunities for governments, businesses, and stakeholders. Four years in, global awareness of the SDGs remains low. How do we not only raise awareness but also create ownership? How do we talk about challenges and the need for accelerated action, while also celebrating progress made? Governments spend significant time and energy putting together VNRs, which are meant to be snapshots of SDG progress -- but what happens before and after the HLPF? Governments are eager for good practices in communicating this ambitious, interconnected Agenda, and several have voiced the desire for support in socializing their VNRs (and more largely, the SDGs) in country. Without quality data, we cannot say with certainty what progress we are making and where gaps exist. One of the main issues identified in the previous VNR lab on data was the disconnect between policy makers and statisticians. As a multi-stakeholder process, the preparation of the VNRs provide a wonderful opportunity to bring these two communities together to discuss how the use of data could be strengthened for robust, evidence-driven VNRs. 15	Wed 17 July	18:30 – 20:00	S-2726/27	<p>Localizing the SDGs and VNRs: reporting on progress, challenges and opportunities</p> <p>Meaningful localization of the SDGs means making these global aspirations of the internationally agreed framework a reality for communities, households and individuals, particularly the most vulnerable and at risk of being left behind. Engaging local populations on SDG localization, including on the process of preparing Voluntary National Reviews, demands strong and tailored awareness-raising efforts, including through the power of local culture and in showcasing how the SDGs are relevant to all people, at all levels. Additionally, a number of local and regional governments have been engaging in preparing voluntary local reviews, adding specific perspectives towards local implementation. 16	Thu 18 July	8:00 – 9:00	CR-11	<p>Catalyzing partnerships for SDG implementation</p> <p>To build momentum for SDG achievement at national and local levels, a range of stakeholders must commit to work together. Governments alone cannot achieve the SDGs and the role of partnerships at the national and local level is particularly important. These can ideally foster synergies among different actors, combine their resources and energies towards addressing specific shared objectives inspired by the SDGs, and enhance mutual accountability. Of the 102 countries that have so far submitted voluntary national review (VNR) reports to the HLPF, almost all mentioned partnerships as a means of implementation. But only a dozen or so referenced explicit efforts to foster partnerships. To help accelerate this slow but gathering momentum at national level and following on from the discussions at the 2019 ECOSOC Partnership Forum on how to build effective country-level partnership platforms, this VNR Lab proposes to bring together diverse actors to discuss, amongst others, how multi-stakeholder partnerships can help drive implementation of the SDGs and what enabling measures would need to be put in place at the country level to foster such multi-stakeholder partnerships.</p>	<p>DSDG, UN DESA <i>Contact:</i> jussila@un.org</p>
