## MGoS plenary session: Introduction Oliver Henman, Moderator

I must also pay tribute to the incredible solidarity that we have experienced across the stakeholder groups in this room.

Recent years have been characterized by war, pandemic and natural disasters, as well as continued reductions in social protection, education, healthcare and other core services. While the direct support for community action and civil society organisations has been drastically reduced.

But we have seen incredible solidarity, kindness and generosity to look after one another in our shared humanity. We have seen strong and dedicated networks of local volunteers who step up to ensure support for communities when even many governments have been paralysed or slow to react.

In the face of crisis or conflict we have seen simple acts of humanity. In the face of disaster we have seen relentless fierce optimism.

We find a common sense of 'we the peoples' and many of the groups you will hear from today have carried out extraordinary steps to bring forward the voices of those who are so often left behind.

In this session we will consider Partnerships for transformative and urgent actions

We will hear from a diverse range of stakeholders who reflect experiences from many backgrounds and regions of the world.
