Remarks by H.E. Mr. Abdulaziz bin Nasser bin Mubarak Al-Khalifa

Mr. President,

Thank you for convening this session of the ECOSOC High-Level Segment on the important topic of "UN at 80: The Role of ECOSOC in Leading Action for a Stronger and More Effective Multilateral System." First, we must reinforce the capacities and coordination of the Functional Commissions. These bodies are instrumental in translating global goals into coherent policies and measurable action. Strengthening them will enhance ECOSOC's overall effectiveness and alignment with the 2030 Agenda.

In this regard, the State of Qatar is honoured to host the Second World Summit for Social Development in November 2025. This major summit will aim to renew global commitment to inclusive, equitable, and just development. We believe ECOSOC has a critical role to play in supporting the implementation of the summit's outcomes, ensuring that social development remains a central pillar of our shared global agenda and that the benefits of global progress are shared equitably.

Second, we believe that deeper alignment between ECOSOC and the international financial institutions is needed to bridge the gap between policy and implementation. Strengthening this connection is essential to mobilizing the resources required to advance sustainable development—especially at this crucial midpoint of the SDGs.

Lastly, we must lead by example. ECOSOC deserves consistent, high-level engagement. Active participation by high-level representation reflects political will and reinforces the legitimacy of the Council's work. The mandates are there—it is our responsibility as member states to use them fully and effectively to tackle today's challenges.

The State of Qatar looks forward to contributing meaningfully to the 2026 intergovernmental review of ECOSOC and the High-Level Political Forum. We see this as a critical opportunity to ensure that ECOSOC continues to serve as a cornerstone of multilateral cooperation in the years ahead.
