1. INTRODUCTION

BACKGROUND AND AIMS OF THE DOCUMENT

The present document is a contribution to the **2021** United Nations High-level Political Forum on Sustainable Development (HLPF), to be convened under the auspices of the Economic and Social Council (ECOSOC) at UN Headquarters.

It was prepared following the letter dated 18 January 2021 from the President of ECOSOC inviting the President of the Human Rights Council to provide substantive inputs to the HLPF showcasing the Council's contribution to the 2030 Agenda in general, and particularly for the Sustainable Development Goals (SDGs) and respective targets that are most relevant to its mandate.

The General Assembly defined the theme of the 2021 HLPF to be "Sustainable and resilient recovery from the COVID-19 pandemic that promotes the economic, social and environmental dimensions of sustainable development: building an inclusive and effective path for the achievement of the 2030 Agenda in the context of the decade of action and delivery for sustainable development".

SCOPE

This document presents an analytical overview of initiatives and actions presented at the Human Rights Council that are directly related to the 2030 Agenda and to the SDGs.

It covers all outcomes of regular sessions of the Human Rights Council that took place after the adoption of the 2030 Agenda for Sustainable Development, in September 2015, namely **from 30th to 46th** regular sessions of the Council.

Although the texts and documents identified in this research specifically refer to the 2030 Agenda for Sustainable Development, it is to be noted that, given the established links between human rights and the Agenda, virtually all activities and outcomes of the Human Rights Council may be understood as contributing to the overall aim of "leaving no one behind".

For the purpose of brevity, the document is accompanied by two annexes containing a summarised version of the data collected as well as analytical graphs that may be useful for further analysis. All information and disaggregated data is available for consultation upon request.

METHODOLOGY

Data for this research was collected by consulting:

- All resolutions, decisions and President's statements adopted by the Council between September 2015 and March 2021, excluding the UPR adoptions.

- All reports submitted by the Secretary-General, the High Commissioner for Human Rights and the Office of the High Commissioner for Human Rights (OHCHR) following a mandated request.

Search keys included direct mentions of the following words: "2030 Agenda for Sustainable Development", "post-2015 agenda" and "Sustainable Development Goals"

Mentions were classified by their location either in the **title** or in the **text** of the document.

It is important to note that this analysis was carried out exclusively on the basis of official documents of the Human Rights Council. Other sources emanating from activities, such as **panel discussions, side events, reports of special procedures and other subsidiary bodies** such as the universal periodic review and the Advisory Committee, were not taken into account at this stage, **unless they were produced in the form of an HC/OHCHR/SG report**. This selection was intentionally made to ensure the highest possible degree of objectivity and transparency, and to serve as a useful basis for any future analysis and initiatives on this matter.

2. FINDINGS

In 2020, the Council adopted **54** resolutions mentioning SDGs, more than in any of the previous years. Previously, the peak of 52 resolutions was reached in 2016, since then, the annual number has been decreasing.

Resolutions adopted in 2020 (and in March 2021) mention SDGs in the context of a variety of topics, including **most economic, social and cultural rights**, such as rights to safe drinking water and sanitation, food, education, work, adequate housing, health (including mental health), development and **civil and political rights**, such as birth registration and freedom of opinion and expression.

Among many **thematic** resolutions, reference to the SDGs was made in resolutions on environment and climate change, local government, NHRIs, good governance, independence of lawyers, safety of journalists, sport, business and human rights, international cooperation. SDGs were also mentioned in resolutions aimed at countering genocide, racism, extreme poverty, female genital mutilation, trafficking in persons, as well as in resolutions aimed at reducing the negative impact of unilateral coercive measures, foreign debt, illicit funds and arms transfer.

Country-specific resolutions referring to the 2030 Agenda in 2020 (and in March 2021), included resolutions on Belarus, Eritrea and Libya.

SDGs were referred to in resolutions concerning the human rights of various **groups**, such as women and girls, children, persons belonging to national or ethnic, religious and linguistic minorities, indigenous peoples, persons with disabilities and persons with albinism.

Resolutions, decisions and President's statements (excluding decisions on UPR outcomes)¹

Between September 2015 and April 2021 (time of writing), the Human Rights Council held 17 regular sessions. It adopted a total of **556 texts (including resolutions, decisions and President's statements and excluding decisions on UPR outcomes)** under all of its 10 agenda items.

A total of **240** texts mentioned the 2030 Agenda and/or the SDGs, representing **43%** of the total number of all adopted texts. Of those documents, **9** specifically referred to the 2030 Agenda in the title. **231** documents mentioned the 2030 Agenda and/or the SDGs in the text (42% of all adopted texts). Reference to the 2030 Agenda and/or the SDGs was made in **391 preambular** and in **198 operative** paragraphs of such resolutions and decisions.

Most instances of mentioning appear in resolutions adopted under **agenda item 3 (88%)**. However, references to Agenda 2030 have become more diversified and have also appeared in resolutions adopted under agenda items 10, 4, 5, 2, 8 and 9 (from more to less frequent).

The intensity of mentioning of SDGs/2030 Agenda varies for different sessions of the Council. The number of HRC resolutions referring to SDGs/2030 Agenda adopted during June sessions tends to be higher: on average, 68% of resolutions adopted in June refer to SDGs, compared to 40% in September and 35% in March.

Reports by the Secretary-General, the High Commissioner for Human Rights, and the OHCHR

Out of a total of **391 reports** by the Secretary-General, the High Commissioner for Human Rights, and the OHCHR presented at the regular sessions under review, **198** contain specific mention(s) of the 2030 Agenda and/or the SDGs, representing the **51%** of the overall total (a 3% increase compared to the 2019 level).

On average, 65% of reports issued for June sessions mention SDGs, while the rate is lower for September sessions (50% of reports) and March sessions (45% of reports).

Since 2016, a total of 9 HC/SG/OHCHR reports focused specifically on SDGs/2030 Agenda:

Specific reports on the implementation of the 2030 Agenda in 2020 (and March 2021)

- Pursuant to Council resolutions <u>37/24</u> and <u>43/19</u>, summaries of the <u>second</u> and the <u>third</u> intersessional meetings for dialogue and cooperation on human rights and the 2030 Agenda were presented under agenda item 3, at the 43rd and the 46th Council sessions, respectively. These reports will be submitted to the HLPF in 2021. The two multi-stakeholder meetings were held on 16 January and 3 December 2019 and illustrated linkages between human rights and the SDGs, particularly at national level. They provided an opportunity for stakeholders to share and exchange good practices and challenges on how integrated approaches to implementing the SDGs and realizing human rights contributed to the fulfilment of the 2030 Agenda.
- At HRC43, OHCHR presented the report on the intersessional seminar on the role of good governance in the promotion and protection of human rights and best practices in the implementation of the Sustainable Development Goals, including Goal 16 in this regard (<u>A/HRC/43/34</u>) under agenda items 2 and 3. It was submitted pursuant to Human Rights Council resolution <u>37/6</u> and contained a summary of proceedings of the half-day intersessional seminar held in Geneva on 14 June 2019.
- OHCHR report on rights of persons belonging to national or ethnic, religious and linguistic minorities (<u>A/HRC/43/28</u>) considers human rights of **minorities** in the framework of the 2030 Agenda.
- HC report on implementation and enhancement of **international cooperation** in the field of human rights (<u>A/HRC/44/28</u>) focused on integrating human rights into national policies for achieving the Sustainable Development Goals.
- At HRC45, Secretary-General and the High Commissioner for Human Rights presented a comprehensive report on **the right to development** (<u>A/HRC/45/21</u>) that focused on the implementation of the right to development in least developed countries, taking into account existing challenges, including the COVID-19 pandemic, and the aim to achieve SDGs.
- HC report on activities in follow-up to the implementation of the programme of activities within the framework of the International Decade for People of African Descent (A/HRC/45/47) focused on the interplay between the 2030 Agenda for Sustainable Development and human rights of people of African descent.

COVID-19 and SDGs in HRC resolutions and HC/SG/OHCHR reports

With respect to the coronavirus disease (COVID-19) pandemic, **two new resolutions** were adopted by the Council, both making reference to the 2030 Agenda:

In its resolution 46/14 'Ensuring equitable, affordable, timely and universal access for all countries to vaccines in response to the coronavirus disease (COVID-19) pandemic',² the Council expressed serious concern over the disparity between developing countries and developed countries in terms of the distribution of COVID-19 vaccines, which prevents the entire international community from achieving the complete elimination of COVID-19 as soon as possible, and hampers progress in the realization of the 2030 Agenda for Sustainable Development. It called for intensified international cooperation to overcome the pandemic and to realize the 2030 Agenda. It also urged States to facilitate the distribution of COVID-19 vaccines and to address the pandemic, in accordance with international human rights obligations and the SDGs and stressed that response to the COVID-19 pandemic should go alongside advancing the realization of the Sustainable Development Goals.

In its resolution <u>44/2</u> 'The central role of the State in responding to pandemics and other health emergencies, and the socioeconomic consequences thereof in advancing sustainable development and the realization of all human rights', the Council recognized that the poor and the most vulnerable people are the most affected by the COVID-19 pandemic, and that the impact of the pandemic will have repercussions on development gains, hampering progress in the achievement of the SDGs. It reiterated the critical importance of the means of implementation of the 2030 Agenda, while being mindful of the impact of high debt levels on States' ability to withstand the impact of the pandemic while advancing sustainable development.

Two specific reports on the impact of COVID-19 were presented to the Council in March 2021:

- HC report on the impact of the coronavirus disease (COVID-19) pandemic on the enjoyment of human rights around the world, including good practices and areas of concern (<u>A/HRC/46/19</u>) considers SDGs in the context of the impact of COVID-19 on poverty and livelihoods, as well as one of the global responses to the pandemic putting in place a new social contract and transforming economies.
- SG report on the impact of the coronavirus disease (COVID-19) on the realization of economic, social and cultural rights (<u>A/HRC/46/43</u>) aligns to the theme of the 2021 high-level political forum on sustainable development. It considers SDGs in the context of recovering better from the pandemic while addressing inequality, creating a new social contract and securing the health of the environment and the planet.
