RE: REQUEST TO PRESENT THE ESWATINI VOLUNTARY NATIONAL REVIEW (VNR) AT THE 2022 UNITED NATIONS HIGH LEVEL POLITICAL FORUM (UNHLPF) ON SUSTAINABLE DEVELOPMENT

The Government of the Kingdom of Eswatini through the Ministry of Economic Planning and Development is in receipt of your letter dated 29th July 2021 informing countries about the Voluntary National Reviews (VNRs) to be conducted at the 2022 United Nations High Level Political Forum on Sustainable Development (HLPF) which will be convened under the auspices of the Economic and
